NOFO Release: June 1, 2026

HUD Deadline: August 26, 2026

Local Competition Opens: Monday, June 15, 2026

Please Note: The HUD deadline is the final deadline for MACH, as the Collaborative Applicant, to submit the full CoC application package to HUD. Project applicants must follow the MACH deadlines below (which are earlier) so applications can be reviewed, scored, ranked, corrected if needed, and submitted on time. If you are applying for funding, your project deadlines are the local **MACH deadlines below and not the August 26 HUD deadline.**

Monday, June 15, 2026	Local Competition Opens/ Documents Posted	FY 2026 local competition materials posted on MACH's website, including local deadlines, applications, scoring tools, ranking process, grievance process, and required attachments.
Friday, June 19, 2026	Reallocation/Reduction/ Transition Letters Sent	MACH sends written confirmation to agencies with projects being reallocated, reduced, transitioned, or otherwise impacted.
Wednesday, June 24, 2026 - Friday, June 26, 2026	Schedule time to meet with MACH Executive Director to ask any questions.	Email cmann@midalhomeless.org for Q&A and Technical Assistance Questions meetings. Please use the following subject line: "FY 2026 CoC Grant Q&A/TA"
Wednesday, July 1, 2026 5:00 PM CST	New Project Local Application	Required for all new projects, transition, reallocation, and DV Bonus applicants. This replaces the LOI/concept form and is intended to be easier for new, faith-based, and community-based applicants to complete. Email to cmann@midalhomeless.org . Please use the following subject line: "FY 2026 CoC Grant - New Project Application"

Date	Activity	Details
Thursday, July 2 - Wednesday, July 3, 2026	New Project Threshold/ Completeness Review	MACH reviews new project Word applications for eligibility, project type, budget, match, service model, local priority alignment, and missing items.
Thursday, July 9, 2026	New Project Corrections/ Attachments Due	MACH sends threshold feedback and identifies any final corrections or missing attachments.
Friday, July 10, 2026 by 11:59 PM CST	Renewal Local Applications Due	Renewal applications and all required attachments due, including match, SAM/UEI, HMIS or comparable database, CE participation, and supportive services participation documentation. Please email to: cmann@midalhomeless . Please use the following subject line: "FY 2026 CoC Grant - Renewal Application" .
Tuesday, July 14, 2026 - 5:00 PM CST	Final New Project Corrections/ Attachments Due	Final new project corrections and required attachments due before scoring by Review Committee.
Wednesday, July 15 - Monday, July 20, 2026	Internal Review Window	No major applicant deadlines due during this period. MACH continues internal review as capacity allows.
Tuesday, July 21, 2026	Renewal Scorecards Released	Renewal scorecards provided to agencies for review.
Friday, July 24, 2026 - 5:00 PM CST	Renewal Scorecard Issues Due	Deadline to submit scorecard questions, correction requests, or N/A scoring concerns.

Date	Activity	Details
Monday, July 27, 2026	Renewal Scorecards Finalized	Final renewal scores locked for ranking.
Thursday, July 30, 2026	New Project Presentations/ Interviews	Required for new project applicants moving forward in the local process.
Friday, July 31 - Monday, August 3, 2026	Ranking Committee Review	Ranking Committee reviews project scores, funding requests, reallocation, CoC Bonus, DV Bonus, and local priorities.
Tuesday, August 4, 2026	Draft Priority Listing Internal Review	MACH completes internal review of draft funding strategy and ranking.
Thursday, August 6, 2026	Draft Ranking Released to Applicants	Applicants receive draft ranking and funding recommendation.
Friday, August 7, 2026 - 5:00 PM CST	Grievances Due	Deadline to submit grievances under the posted local grievance procedure.
Monday, August 10, 2026	Final Grievance Review/ Ranking Finalized	MACH finalizes ranking and funding recommendations.
Tuesday, August 11, 2026	Final e-snaps Revisions Due	Applicants complete final e-snaps revisions requested by MACH.
Monday, August 17, 2026 - 5:00 PM CST	Final Project Applicants Locked Locally	No further project edits unless requested by MACH.
Monday, August 17 - Wednesday, August 19, 2026	CoC Application Finalization	MACH finalizes the CoC Application, Priority Listing, attachments, and project review documentation.

Date	Activity	Details
Thursday, August 20, 2026	CoC Application Posted for Public Review	Consolidated Application and Priority Listing posted for public review before HUD submission.
Monday, August 24, 2026	Public Comment Closes	MACH reviews final comments and completes final edits.
Tuesday, August 25, 2026	Target HUD Submission	MACH target date to submit before the federal deadline.
Wednesday, August 26, 2026 - 7:00 PM CST	HUD Final Deadline	Final federal submission deadline.

Required Attachment Note: Required attachments are due with the applicable local application deadline. Renewal attachments are due with the renewal local application. New project attachments are due with the new project application or by the final correction deadline in MACH requests revisions.

Required Applicant Notification Note: MACH will notify applicants in writing whether their project is accepted/ranked, reduced, or rejected no later than **August 11, 2026**. If a project is reduced or rejected, the notice will include the reason for that decision.

Public Posting Note: MACH will post the CoC Consolidated Application and Priority Listing for public review before the final submission to HUD.
